NATIONAL PARKS

POSSIBLE ESTABLISHMENT OF INTERPROVINCIAL PARK IN TÉMISCAMINGUE—REPRESENTATIONS FROM CITIZENS' GROUPS—DISCUSSIONS WITH ONTARIO AND QUEBEC

Mr. Réal Caouette (Témiscamingue): Mr. Speaker, I should like to direct a question to the hon. Minister of Indian Affairs and Northern Development, in charge of national parks.

On many occasions when I asked him questions about the Témiscamingue national park, the minister replied that he was to discuss the matter with the premier of Quebec. Is the minister aware that people are now talking about an interprovincial park that would include the Mattawa area in Ontario and that of Témiscamingue? If so, could he tell us about the progress of the discussions?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, I am aware of the new proposal to the effect that citizens from Ontario would like the park to include areas on both sides of the frontier. We also discussed the matter with the Ontario government but have not received any answer yet.

Mr. Caouette: On a supplementary question, Mr. Speaker.

Did the hon. minister receive representations from the council of Témiscamingue county to the effect that it would be preferable to create a national park in Témiscamingue without any areas from another province?

Mr. Speaker: Order. The question as asked is not in order. The hon, member is asking the minister whether he received representations to that effect.

Mr. Caouette: Mr. Speaker, I will rephrase my question.

As regards that interprovincial park, is there any opposition from the citizens of Témiscamingue? If so, what has the minister told them?

Mr. Chrétien: Citizens on the Quebec side would like the park on their side alone, people from Ontario would also like to have it on their side alone; as a good federalist, I think it might be wise to set it up on both sides.
