# POST OFFICE

POSSIBLE INCLUSION OF AUTOMATION IN CONTRACT NEGOTIATIONS

Hon. W. G. Dinsdale (Brandon-Souris): Mr. Speaker, may I direct a question to the Postmaster General which arises from the extreme sensitivity of the contract negotiations now under way with postal employees and the possible importance of technological change in these negotiations? Can the Postmaster General give assurance that automation will be included in the negotiations?

Hon. Bryce Mackasey (Postmaster General): Mr. Speaker, my personal philosophy is that the effects of automation should be a subject for negotiation with employees. We are now in the middle of collective bargaining and it is during a period of negotiations that anything is possible. But it takes two to tango and the union in question has to show a propensity for bargaining in good faith.

Mr. Dinsdale: A supplementary question, Mr. Speaker. As the hon, gentleman included automation in his amendments to the Labour Code when he was minister responsible for that department, would be now use his influence to ensure that this important principle is included in the current negotiations with the post office workers, particularly as it has been publicly said by the employees that this inclusion is essential to any settlement.

Mr. Mackasey: Fortunately, Mr. Speaker, the particular set of rules under which the Post Office negotiates are now before a special joint committee of the Senate and the House of Commons. This matter is topical and changes no doubt will be brought forward in the area soon. I, personally, hope that this progressive type of legislation introduced in the Labour Code will be extended to public servants.

PROPOSED UPGRADING OF COMMUNICATIONS IN REMOTE AREAS

Jamieson (Minister of Regional Economic Expansion): Mr. Speaker, the only direct request or representation I have had so far on this matter, other than individual requests like those of the hon. member, have been within the province of Ontario where, as he may know, reference was made prior to Christmas to intentions by the government of Ontario with regard to expanding a communication network into some of the more remote regions of the province, and the possibility of DREE involvement in that kind of project is being considered. I assume that could be begun as a kind of pilot project. In principle, I see no reason why agreements with the provinces should not be entended to cover some forms of communication under the heading of infrastructure.
