That the Solicitor General, on motions, indicate to what extent social insurance numbers are used in matters other than social insurance-related investigations and issues in his department and what limitations or safeguards. if any, are implemented by the Minister of Employment and Immigration.

REPRESENTATIONS THAT DANYLO SHUMUK BE ALLOWED TO IMMIGRATE TO CANADA FROM U.S.S.R.—MOTION UNDER S.O. 43

Mr. Mark MacGuigan (Windsor-Walkerville): Mr. Speaker, I rise, under the provisions of Standing Order 43, on a matter of urgent and pressing necessity. My motion concerns Danylo Shumuk, a Ukrainian patriot who is reported to be dying of stomach cancer in the Soviet Union. Last Wednesday, the hon. member for Burnaby-Richmond-Delta (Mr. Siddon) moved a motion on this matter, and I believe there might have been unanimous consent at that time. In any event, I think there may be unanimous consent this morning. In light of the fact that the Soviet labour code itself provides that in the case of serious illness such a person may be released from prison, I therefore move, seconded by the hon. member for Saskatoon-Biggar (Mr. Hnatyshyn):

That this House strongly urges the Soviet government, taking into account Danylo Shumuk's ill health, to release him from prison.
