# UNEMPLOYMENT INSURANCE

REGULATION AFFECTING PART-TIME AGRICULTURAL WORKERS

Hon. John Wise (Elgin): Madam Speaker, my question is directed to the Minister of Employment and Immigration, and is prompted because of the difficulty which certain Order in Council changes, or regulatory changes in the Unemployment Insurance Act, have caused part-time workers, particularly agricultural workers. Would the Minister tell us what consultation, if any, took place between his Department and agricultural producers prior to the regulatory change being made and prior to its inception date of January 1 of this year? What consultation, if any, took place?

Hon. Lloyd Axworthy (Minister of Employment and Immigration): Madam Speaker, in this particular situation, as I pointed out to the House, I believe, two days ago, we were faced with the problem of a number of workers in the agricultural field not receiving the proper income security which other occupations would receive for comparable work. We brought forward these regulations, having had some discussions over the years about that particular implementation.

It has been brought to our attention since then that certain agricultural associations had difficulty implementing the program to the fullest extent, so we have undertaken some very serious negotiations, very ably aided by members of my caucus who represent agricultural areas. The Hon. Member for Essex-Kent and others have been meeting over the past two weeks with the Horticultural Society. I think we now have the problem well in hand and we will be making amendments to that order which will be satisfactory to the agricultural groups.

### REQUEST THAT REGULATION BE SUSPENDED

Hon. John Wise (Elgin): Madam Speaker, I know consultations have gone on in the last few days. I also appreciate the fact that seven days are certainly better than 15 hours. But in view of the fact that certain agricultural producers have as many as 400, 500, sometimes 600 people working in the field at one time, and in view of the complications this causes for the producer, would the Minister give serious consideration to suspending this regulation for at least a 12-month period and begin serious negotiations and consultation with the people in the agricultural industry? Would he give serious consideration to that in view of the problems being caused?

Hon. Lloyd Axworthy (Minister of Employment and Immigration): No, Madam Speaker. I believe it is important to maintain the protection afforded agricultural workers, and I

think that is a commitment we have made particularly because those workers are on the lower end of the income scale and therefore need that security we can provide. I do believe that the resolution to the problems which have been worked out in the consultations, providing a leeway of seven days, will be satisfactory and eliminate the paper work for the temporary workers. I think under those circumstances we can relieve the producers of further headaches. I also believe that is satisfactory to them.
