Foster, whose hands had been deep in the money of widows and orphans of Ontario. In New Brunswick he was trailed by Geo. W. Fowler who had told Lefurgey to keep him until they got the money. In Quebec Mr. Borden had Mr. Rufus Pope, one of the executive who had handled the money, and in Chatham he had Mr. Matthew Wilson, chairman of the Union Trust Company. Mr. Borden trailed around with the men whom Sir McKenzie Bowell had called "a nest of traitors" men who had betrayed Bowell and his Government. These were the men Mr. Borden compared to Sir Wilfrid Laurier and his Government against whom there were no stain.

The Minister of Justice, Mr. Aylesworth gracefully acknowledged the splendid reception given him,

and began to discuss the scandal campaign indulged in by Mr. Borden and the Conservative press. It appeared that the 47 Conservative members from Ontario had determined to wage the same kind of campaign of vilification waged during the last election for the Ontario House. Since this policy of scandal had been introduced, the Liberals had redeemed North Bruce, and only the other day Hon. Mr. Pugsley had been returned by acclamation in a constituency that gave a Conservative majority of 800 at the last general election. In spite of the presence of Mr. Borden in St. Johns months ago, and in spite of the scandal campaign waged by the Conservatives since then, the party in New Brunswick knew that if they opposed Mr. Pugsley they were certain to have gone down to ignominious defeat. They did not even nominate a candidate. The party had followed a consistent policy of detraction, slander and abuse, and seemed to have liberally adopted that policy, and it seemed to be the intention of the party to carry out that policy in the coming general election. If that were the case the Liberal party was ready to meet their antagonists on their own ground. They had nothing to fear. The Liberal Government's administration and legislative record was absolutely impregnable. Mr. Borden had willingly lent himself to this policy of mud throwing and abuse. At Chatham he declared that Hon. Mr. Fielding knew that his own riding had been debauched. "I know Mr. Fielding," said Mr. Aylesworth, "the people of this country know him, and I venture to say that there is not an honest and right-thinking man who does not believe that Hon. Mr. Fielding is as clean

and honest a statesman as ever drew the breath of life. Last week at a public meeting in Dundas I read an extract from Mr. Borden's speech, and I had a word or two to say by way of answer. Since then the newspapers of this Province have been profuse in their accounts of challenges to wordy war and combat. From Mr. Borden to myself, I was waited upon not long ago by the representative of a Toronto newspaper who wanted to know where I would meet Mr. Borden. I had no other answer to make than that I had met him before the floor of the House, and would meet him there again. Mr. Borden will be welcome if he comes to any meeting where I happen to be present. I shall be pleased to see and meet him. But it is a vain and idle thing that he, as champion of the Conservative party, should go about vilifying and challenging his opponents to meet him. Does he think that I am going to follow him? I am here, let him come, I said before in referring to Mr. Borden that he had better look to his own case, and I said what I am prepared to uphold anywhere and before any tribunal in this country, that certain statements of what the petitioners in the Halifax election case said they could prove with regard to Mr. Borden's own connection with corrupt practices at the late Dominion general elections had been submitted to me, and I expressed my opinion on those statements as any lawyer might. I said what I repeat today that if these things were established at the trial, Mr. R. L. Borden would stand elevated for eight years from the House of Commons in Canada."

This money had been expended for legitimate purposes, and he saw to it that the figures were given publicity to. Did any person imagine that publicity had been given in the manner in which the \$30,000 had been spent? Could anyone tell how it had been expended? If so, now was the time to speak.

Further extracts from Mr. Graham's testimony were read by Mr. Aylesworth. These told how various sums of money had been sent to the organizers in a number of districts, and by arrangement with the organizers to the organizers in their own names, but as Zandry, Zanduck, Zandring, and Zandried.
