

By the Honorable Mr. *Bosford*,—Of the Maritime Bank of the Dominion of Canada, and, also of the *New Brunswick Railway Company*.

Pursuant to the Order of the Day, the following Petitions were severally read :—

Of the North-Western Coal and Navigation Company (Limited), a Company incorporated under "The Companies Acts, 1862 to 1880," of the Imperial Parliament; praying for the passing of an Act permitting them to build and work Railway and Telegraph or Telephone lines from a point on the Canadian Pacific Railway to their Mines on *Belly River*, and Westerly to *Fort MacLeod*, and with powers to sell, lease or amalgamate with any other Company.

Of the Honorable Sir A. T. *Galt*, and others; praying to be incorporated as "The *Alberta Railway and Coal Company*."

The Committee carefully examined the following documents, and recommend that they be printed, viz. :—

Report of the Librarian of Parliament. (No. 17). (*Sessional Papers only*).

Statement of payments charged to unforeseen expenses by Orders in Council, from 1st July to date. (No. 18). (*Sessional Papers only*).

Statement of the name and rank of each person superannuated or retired, the allowance granted him, and the cause of his superannuation, &c. (No. 19). (*Distribution only*).

Return (in part) to Order (1883) showing separately for each year,—

1. The number of persons on the list for the year as entitled to the benefit of the Act.

2. The number superannuated during the year under the Act.

3. The number retired during the year on a gratuity under the Act.

4. The total amount paid into the fund from the beginning by those who were during the year superannuated, or retired on a gratuity, distinguishing between those whose superannuation was caused by the abolition of office, those who were superannuated otherwise, and those who retired on a gratuity.

5. The number of persons on the list for the year who died in the service; and

6. The total amount paid into the fund from the beginning by those who during the year died in the service. (No. 19a). (*Distribution only*).
