

Then, on motion of the Hon. D. Davies, seconded by the Hon. the Solicitor General,

Resolved, That the said Report be adopted.

The Hon. J. C. Pope, from the Committee appointed to receive tenders for printing the Debates of the House, for the present Session, and to report thereon to the House, presented to the House the report of the said Committee; which report was again read at the Clerk's table and is as followeth :—

Your Committee appointed to receive tenders for printing the debates of this House for the present Session, have to report that they have received four tenders, viz :—

First—From John Ings, Esquire, offering to print the "Parliamentary Reporter" at thirty-one shillings and nine pence per sheet of four pages, and to bind the same for ten pence per copy; the debates to be published in the *Islander* newspaper.

Second—From Mr. F. W. Hughes proposing to print the debates in the usual style of the "Parliamentary Reporter" on superior English paper, at fifteen shillings and six pence per sheet of four pages; if on inferior paper, fifteen shillings per sheet; and to bind the same in the usual style at nine pence each copy; the debates to be published in the *Examiner* newspaper.

Third—From Mr. David Laird offering to print the "Parliamentary Reporter" for forty shillings per sheet of four pages, and to bind the same for one shilling per copy; if published in the *Patriot* newspaper, the price to be fifty shillings per sheet.

Fourth—From Mr. Edward Reilly undertaking to print the "Parliamentary Reporter" in the usual style for the sum of thirty-five shillings per sheet of four pages, and to bind the same for one shilling per copy; if the debates be published in the *Herald*, the price to be forty-five shillings per sheet.

Your Committee are of opinion that the proposal of Mr. F. W. Hughes to publish the "Parliamentary Reporter" on superior English paper, as per specimen furnished, marked No. 1, for fifteen shillings and six pence per sheet of four pages, and to bind the same for nine pence per copy, be accepted. The debates to be also published in the *Examiner* newspaper.

Then on motion of the Hon. J. C. Pope, seconded by the Hon. the Solicitor General,

Resolved, That the said report be adopted.
