- No. 1.—Select Standing Committee on Industrial and International Relations: Second Report recommending that 750 copies in English and 200 copies in French of this report and the evidence which it is based, be printed in blue book form, and that Standing Order 64 in relation thereto be suspended. *Printed* in Blue Book form only. *See Journals* at pages 338, 457.

- No. 5.—Special Committee appointed to study the Dominion Elections Act, 1920, and the amendments thereto, and the Corrupt Practices Inquiries Act, in accordance with the recommendation contained in the second and final report of the Select Standing Committee on Privileges and Elections, which was concurred in by the House on the 5th of June, 1928: Fifth and Final Report submitting and recommending for the consideration of Parliament at its next session, amendments to The Corrupt Practices Inquiries Act, and also amendments to The Dominion Elections Act. *Not printed.* *See Journals* at page 551-8.
