

On motion of Mr. Henderson, seconded by Mr. Simmons, it was ordered,—That the petition of Margo Jean Thornton Savard for a bill of divorce, presented on February 28, 1957, together with the Clerk of Petitions' Report thereon of March 1st, 1957, be referred to the *Standing Committee on Standing Orders* for such recommendations as may be deemed advisable.

On motion of Mr. Harris, seconded by Mr. Campney, it was ordered,—That items numbered 172 to 184 inclusive, relating to the Department of Justice; items numbered 396 to 405 inclusive, relating to the Royal Canadian Mounted Police; and items numbered 435 to 453 inclusive, 456 to 464 inclusive, 467 to 496 inclusive and 532 to 535 inclusive, relating to the Department of Transport, as listed in the Main Estimates 1957-1958, be withdrawn from the Committee of Supply, and referred to the *Special Committee on Estimates*, saving always the powers of the Committee of Supply in relation to the voting of public moneys.

The following Bill from the Senate was read the first time and ordered for a second reading at the next sitting of the House:

Bill No. 209 (Letter F of the Senate), intituled: "An Act to amend the Territorial Lands Act".—*Mr. Lesage*.

The following Government Notice of Motion, having been called, was transferred to Government Orders for consideration at the next sitting of the House, pursuant to Standing Order 21(2):

That a Sessional Committee on Railways and Shipping owned, operated and controlled by the Government, be appointed to consider the accounts and estimates and bills relating thereto of the Canadian National Railways, the Canadian National (West Indies) Steamships, and Trans-Canada Air Lines, saving always the powers of the Committee of Supply in relation to the voting of public moneys; and that the said Committee be empowered to send for persons, papers and records and to report from time to time and that, notwithstanding Standing Order 67 in relation to the limitation of the number of members, the said Committee to consist of Messrs. Bell, Byrne, Carter, Cavers, Follwell, Fulton, Gauthier (Lac-Saint-Jean), Gillis, Hahn, Hamilton (Notre-Dame-de-Grâce), Hamilton (York West), Hanna, Harrison, James, Johnston (Bow River), Knight, Lavigne, Legaré, McCulloch (Pictou), Mitchell (Sudbury), Murphy (Westmorland), Nowlan, Power (Quebec South), Richardson, St. Laurent (Témiscouata), and Weaver.

Mr. Howe (Port Arthur), seconded by Mr. Harris, moved,—That the House do go into Committee of the Whole at its next sitting to consider the following proposed Resolution which has been recommended to the House by His Excellency:

That it is expedient to introduce a measure to amend the Prairie Grain Producers Interim Financing Act, 1956 to enable the Governor in Council to extend the application of the Act to authorize and govern guaranteed loans that may be made by banks in the period September 1, 1957 to June 1, 1958; to provide that the rate of interest charged by the banks on a loan shall not
