EXPENDITURES IN CANADA BY U.S. INTELLIGENCE AGENCY

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, information has just been brought to my attention as a result of which I should like to direct a question to the Prime Minister, who may require some time before answering. This question relates to the extraordinary and completely unjustifiable conduct of the Central Intelligence Agency of the United States as revealed recently regarding the secret transfer of large amounts of money to organizations outside the United States. Will the Prime Minister communicate with the administration in Washington to ascertain what moneys, if any, were expended by the C.I.A. to Canadians during the period between May of 1962 and June of 1963? I refer to those amounts of money in addition to what was given to one student organization, the facts of which are now public knowledge.

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, I will be glad to look into this matter.
