**Mr. Macquarrie:** May I ask the right hon. Prime Minister whether the Secretary of State for External Affairs was speaking for the government at that time?

**Mr. Trudeau:** Yes, Mr. Speaker, he was speaking for the government.

## PROPOSED TRANS-ALASKA PIPELINE SYSTEM—REQUEST THAT COMMITTEE INQUIRY BE PROCEEDED WITH

**Mr. David Anderson (Esquimali-Saanich):** A supplementary question, Mr. Speaker. In light of the revelations at the United States Senate hearing yesterday, where it was obvious to Secretary of the Interior Morton and others that further studies would have to be made, may I ask the Prime Minister once more whether or not at this stage he is willing to instruct the government House leader to withdraw his untimely support for the Conservative motion which prevented this House from carrying out such a study on the effects in Canada?

**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, I have raised the matter with the House leader and we did indeed discuss it. We feel that the matter should indeed be seized by parliamentarians, but there is a committee on national resources, I believe, that is also enabled to study such matters. Consideration will be given to the form in which discussions can take place.

Mr. Anderson: Mr. Speaker, in view of the fact the House has no knowledge whatsoever of the committee on national resources seizing itself of this problem, and as we have no advice or information that the House will instruct that committee to take up this problem, may I ask the Prime Minister whether he will ask one of his ministers responsible to give instructions through the House to that committee to carry out such a study?

**Mr. Trudeau:** Mr. Speaker, the position is that there are other members of other committees who can do this job equally as well, and it is a matter of deciding which committee should be doing this job.

An hon. Member: Hard luck!

Some hon. Members: Oh, oh!

**Mr. Speaker:** Order, please. I believe the Leader of the Opposition has a supplementary question.
