## FULL INDEXATION OF FAMILY ALLOWANCE

Mr. Steven W. Langdon (Essex-Windsor): Mr. Speaker, I have four petitions to present today. The first comes from Vancouver in British Columbia and is a petition protesting the family allowances deindexation and asking that they not be offset by changes to the child tax credit because then even the poorest families will be worse off by 1990.

The second petition comes from New Brunswick and stresses the cut-backs in child benefits of \$600 million by 1990 which will be part of the set of unfair tax changes put into place in the last Budget.

The third petition comes from Nova Scotia and stresses that these reductions in family allowances comes with an increase in RRSP deductions, an increase in hand-outs to the oil companies, and therefore makes our tax system more unequal.

Mr. Speaker, my fourth petition comes from the Province of Quebec, from the cities of Terrebonne, LaSalle, Saint-Jérôme and Montreal. These petitioners also protest against lower family allowances and urge the Government to change its policies.

UNEMPLOYMENT INSURANCE—PENSION INCOME DEDUCTIONS

Mr. Howard McCurdy (Windsor-Walkerville): Mr. Speaker, I have a number of petitions, the first of which protests the government decision to have pension benefits deducted from unemployment insurance benefits, thus effectively removing a significant benefit from workers and creating a disincentive for early retirement plans, and asking for the immediate withdrawal of that action.

# FULL INDEXATION OF FAMILY ALLOWANCE AND REPEAL OF TAX INCREASES

Mr. Howard McCurdy (Windsor-Walkerville): The second petition is from New Brunswick and it protests the intention to deindex family allowances and requests the reinstatement of full indexation of the universal family allowance and the recission of the unfair tax increase.

I have another petition of a similar nature from Vancouver protesting the intent to deindex the family allowances and protesting other measures with respect to childhood benefits, the unfair tax changes and asking that those tax changes be withdrawn.

Another petition is from Nova Scotia from citizens there exercising their anxious right to petition the Parliament of Canada in protestation against the changes in the family allowances and asking that that action be rescinded as well as those with respect to taxation.

Finally, I have a petition from the Province of Quebec, from citizens there exercising their anxious right to protest the changes in family allowances, specifically their deindexation, asking that that action be withdrawn and that the tax changes affecting low and middle-income people be rescinded.

Mr. John Parry (Kenora-Rainy River): Thank you, Mr. Speaker. It is my privilege today to present two petitions signed by residents of my riding. The first protests the action by the Government in cutting back family allowances and in instituting tax increases which will further increase the burden on ordinary families in Canada. This petition is signed by residents of Red Lake, Madsen and Balmertown.
