Mr. Riis: Mr. Speaker, the purpose of the Bill is to add the Administrator to those offices of the House of Commons that are responsible for preparing the estimates of the sums required for the House. The Board of Internal Economy and

the House have now been organized with an Administrator who is doing an excellent job, and we felt that this would be an appropriate person to be responsible for preparing the estimates for the House of Commons.

Motion agreed to, Bill read the first time and ordered to be printed.

CANADA ELECTIONS ACT

MEASURE TO AMEND

Mr. Nelson A. Riis (Kamloops—Shuswap) moved for leave to introduce Bill C-268, an Act to amend the Canada Elections Act.

Mr. Speaker: Shall the Hon. Member have leave to introduce the said Bill?

Some Hon. Members: Agreed.

Mr. Riis: The purpose of this Bill is to allow urban voters to be sworn in and vote on election day when their names fail to appear on the voters' list for urban polling divisions. It is the same procedure that is presently available for rural voters.

The Bill would also attempt to remedy the situation where candidates and their canvassers have been denied entry to apartment buildings, hotels, and the like, which have no soliciting policies in place.

It would also allow travellers and students, who are temporarily resident outside of Canada, to vote in general elections in a manner similar to the Canadian Armed Forces and the Public Service electors who are presently posted outside of Canada.

Motion agreed to, Bill read the first time and ordered to be printed.
