we have made, that only 5 per cent will be there. It could be more.

I want to point out to the Hon. Member that if there is a greater degree of competition, as will come from the free trade agreement, possibly we will see a greater increase in the price reductions as a result of the free trade agreement. Nothing is hidden whatsoever.

DEPARTMENT'S STUDY

Mr. Steven W. Langdon (Essex—Windsor): In fact, Mr. Speaker, it is precisely that misleading approach which the Government has taken in another one of its propaganda documents, the one talking about Canadian consumers and the benefits they will get from the trade deal. It says precisely: "Retailers will pass on to consumers the price reductions resulting from the elimination of tariffs under the agreement". That comes directly from the Consumer and Corporate Affairs Ministry's study which was issued after that December 16 memorandum.

Why is the Government, at taxpayers' expense, putting out misleading propaganda which is telling consumers something that is not true?

Hon. Michael Wilson (Minister of Finance): Mr. Speaker, quite frankly I think this is total distortion of what we are trying to do. In the analysis that we have provided on the free trade agreement we have said that there will be a reduction, in our judgment, of 5 per cent on the price of consumer goods. That takes into account a judgment that we have made that the full savings would not be passed on to consumers. However, if the full savings are passed on to consumers, then that 5 per cent will be a larger number. Surely that is not distorting or misleading the consumer.

As I said in my previous answer, if we had not made that more conservative assumption the Hon. Member would be standing up and saying, in a voice of feigned outrage, that we have been exaggerating the impact of the free trade agreement. This has been a conservative, realistic approach to the effects of the free trade agreement.

Mr. Langdon: Yes, but it is not the approach that was taken by the Government's own study from another Department, which was misleading and classifies absolutely as false propaganda.

INQUESTS INTO TORONTO DEATHS
