Some Hon. Members: Yea.

The Acting Speaker (Mr. Paproski): All those opposed to the motion will please say nay.

Some Hon. Members: Nay.

The Acting Speaker (Mr. Paproski): In my opinion the nays have it.

The Acting Speaker (Mr. Paproski): Pursuant to Standing Order 76(8), the recorded division on the proposed motion stands deferred.

We are now at Motions Nos. 10 and 11 which will be grouped for debate and voted on as follows: an affirmative vote on Motion No. 10 will obviate the need for a vote on Motion No. 11. However, a negative vote on Motion No. 10 will require a vote on Motion No. 11.

Mr. Rodriguez: Mr. Speaker, I rise on a point of order. There was a misprint in the *Order Paper*, and where it says biodegradable laundry detergents, it should read non-biodegradable laundry detergents.

Mr. Gauthier: Mr. Speaker, on the same point of order, first, as in prior motions, we would be agreeable to giving our unanimous consent, which is required in this case, for someone from the party on my left to move that motion in its proper form and wording. If he or she wants to move it with non-biodegradable, it is up to him or her to make the motion at this time.

Mr. Rodriguez: Mr. Speaker, seeking the unanimous consent of the House, I move:

That Motion No. 10, standing in the name of Ms. McLaughlin be amended to read after Clause 8, "non-biodegradable laundry detergents".

The Acting Speaker (Mr. Paproski): Is there unanimous consent?

Mr. Hawkes: Mr. Speaker, if indeed there is an error, we have absolutely no objection to correcting the error. The Chair might want to look to see whether or not that change is in order.

Mr. Riis: I appreciate the comment made by the government Whip, and I suspect that with unanimous consent it would be in order. I just want to take this opportunity to thank the hon. member for Ottawa—Vanier for his suggestion for both the government's as well as the Official Opposition's co-operation on this change.

The Acting Speaker (Mr. Paproski): I see no problem with that. We have unanimous consent.

Mr. John R. Rodriguez (for Ms. McLaughlin) moved: Motion No. 10.

That Bill C-20 be amended in Clause 8 by striking out line 10 at page 5 and substituting the following therefor:

"8. Non-bio-degradable laundry detergents."

Motion No. 11
