On motion of Mrs. Carman, the usual privileges of the Convention were accorded to the returned missionaries present.

The Nominating Committee presented its report, and committees were formed on Memorials and Resolutions, Candidates, and Courtesy.

On the nomination of the Secretary, Mrs. Powell and Mrs. Browne were appointed Press Reporters, and Mrs. Copeland, Assistant Secretary.

The Executive Report, the Reports of Branches, of the Standing Committees, and of the Secretaries and Treasurer of the Board, were all adopted, and are printed in this Annual Report. In the President's address, which was full of inspiration, the suggestion was made that "The Story of the Year," published in an attractive pamphlet form, with illustrations, might greatly extend the interest in the work of the Society.

Mrs. McKay presented the report of the Memorial Committee. Motions of which notice was given last year, were considered first.

It was ordered that Article V, Section 1, of the Constitution, be amended to read, "one to every one thousand members."

Also that Article V, Section 1, and Article VI, Section 2, be amended to provide for the election "by ballot without nomination" of delegates to the Board and Branch officers.

The three following were rejected:

That the fee for Mission Band members be twenty-five cents for those over eight years, and ten cents for those under eight years.

That Article V, Section 2, be amended to include the Superintendents of Systematic Giving among the Branch officers.
