interest, even by those not immediately concerned. Naturally the Mississippi valley interest, which is very powerful, will tend to cast itself into the balance on Chicago's side. This with regard to the proposed legislation. The attitude of the United States Supreme Court, on the question whether Chicago has already taken what does not belong to her, will be based on the law and on justice, presumably with due regard for the natural right of all who dwell on navigable waters to their normal flow.
