Had the affairs of the Committee in the sarly part of the year been transacted in a busines: like manner, and the funds appropriated for the various works been scrupulously spent where they ought to have been, the Council would have had infinitely more con-fidence in the willingness or ability of the Chairman to spend aright what money they might have voted, even though he had not furnished a detailed statement. But after the gross blundering and mismaage-ment which were clearly established by tue Special Committee, no excuse or argument would justify the Coun-cil in handing over a sum of money without knowing where-t was to be spent.
