There is a part of Saltfleet township in it that will retain the name, and I do feel that Hamilton-Barton would have been a better name to have called this riding, which is now Hamilton South. I merely repeat it is with regret on my part that I have to lose all these good people, but I realize that something had to be done in Hamilton. I think this plan is a good one. I have no complaints about that new riding, because I think it is probably the best plan that could have been arranged in the circumstances.
