Mr. Balcer: Mr. Speaker, I have not read that particular item, but I feel that the house can have full confidence in the Minister of Transport.

If settlement of this matter merely requires putting something down in writing, as the hon. member for St. Denis has indicated, the Minister of Transport is certainly able to do so.

My question is, will the choosing of this site be left directly to the Ontario hydro, or will the federal government be consulted?

Hon. Gordon Churchill (Minister of Trade and Commerce): In answer to this question may I say that there will be consultations among all the parties concerned, Ontario hydro, the government of Ontario, the federal government, Atomic Energy of Canada Limited and so on.

Mr. Robinson: A supplementary question. Since the federal government will be taking part in the choosing of a site, will the minister assure the house that the district known as the Bruce peninsula will be looked at, owing to the fact that it has the proper rock foundations which are necessary for such construction, and also an unlimited supply of clear blue water?
