Mr. MacEachen: 1. Under the winter house building incentive program, 1,468 applications for certification were received in respect to structures built in the province of Manitoba.

2. Out of this number of applications 1,255 qualified for the incentive payment.

3. The numbers of qualified applicants in the specified municipalities are as follows: (a) metropolitan Winnipeg, 934; (b) Brandon, 69; (c) Flin Flon, 4; (d) Portage la Prairie, 14; (e) Selkirk, 36; (f) Dauphin, 3; (g) Gimli, 1; (h) Stonewall, nil.
