Questions

He said: Mr. Speaker, it has been necessary to resubmit this bill, which has been approved by the house in committee and upon which the government promised action in the Speech from the Throne of the session before the present one.

The need for an ombudsman or parliamentary commissioner becomes more and more urgent with the continuing development of bureaucratic government. This bill has therefore been resubmitted this session so as to provide further for the protection and representation of Canadian citizens.

Motion agreed to and bill read the first time.

Question No. 1-Mr. Coates:

- 1. What was the objective of the Canadian corporation for the 1967 world exhibition in producing a calendar for distribution and how many of these calendars were produced and distributed?

- 4. Was a competition held to select the design?
- 5. Who printed the calendar, were tenders called and what was the cost of the printing?

Hon. Robert Winters (Minister of Trade and Commerce): 1. The object of the count down calendar was as a promotional device to emphasize and to remind everyone of the ever decreasing number of days remaining before the opening of the exhibition. The calendar was sent to Canadian business, foreign business, to the newspapers, to potential sponsors to the exhibition, to foreign delegations and participants, etc. There were 15,300 count down calendars printed, of which 14,500 have been distributed.

- 2. The designers were Paul Arthur Associates and Southam Specialized Marketing Services.
- 3. Total cost of the calendar was \$11,877.14 including federal sales tax and shipping charges.
- 4. No. The design was the creation and unique idea of Paul Arthur Associates and Southam Specialized Marketing Services.
- 5. The printer was Southam Specialized Marketing Services and the contract price was negotiated. Cost of printing including design, etc., was \$10,528.50.
