NON-PAYMENT BY HEAD OF QUEBEC SEPARATIST MOVEMENT

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, my question is directed to the Minister of National Revenue. It is asked because of the number of income taxpayers, who have read the statement of Pierre Bourgault, head of the Ralliement pour l'Independance Nationale, who says he has not filed any income tax return since 1963, that he refuses to pay income tax, and the government is afraid to go ahead against him; that it has in no way asked him to pay [Mr. Speaker.]

income tax since he told the government three years ago that he did not recognize the laws of Canada.

Mr. Speaker: Order, please. Since this is a matter, as indicated in the question of the right hon. Leader of the Opposition, which seems to have been extant for some years I am not sure whether it is in order now.

Mr. Diefenbaker: This is something which has just come out in the press. Canadian taxpayers want to know if there is one law for the separatists and another law for the rest of us.

Hon. E. J. Benson (Minister of National Revenue and President of the Treasury Board): Mr. Speaker, I wish to assure the right hon. gentleman that if the situation as outlined by him is correct, my department, which is not afraid to collect taxes, will make every effort to collect taxes from this individual as it would from every other Canadian. We treat all Canadians in the same way, whether they are separatists or not.

Mr. Diefenbaker: Then go ahead.

Hon. George Hees (Northumberland): A supplementary question to the Minister of National Revenue. Considering that this matter appears to have been going on for some four years, with this man claiming he has not paid taxes for that period, would the minister report on this matter on Monday?

Mr. Benson: Mr. Speaker, I must obey the practice of this house and not report to the house on the tax affairs of individual tax-payers. I wish to assure the hon. gentleman, however, that the department will make every effort to collect every dollar of tax that is owing to the government of Canada.

Mr. Diefenbaker: He says you have been asleep for the last three years.

Mr. Lawrence E. Kindt (Macleod): Will the minister in the administration of this matter adhere to the principle of applying the appropriate penalties?
