### SOCIAL SECURITY

#### FAMILY ALLOWANCES—INQUIRY RESPECTING METHOD OF PAYMENT

**Mr. Gilbert Rondeau (Shefford):** Mr. Speaker, I have a question for the Minister of National Health and Welfare.

In view of his answer to the hon. member for Portneuf and in view of the fact that the government of the province of Quebec informed the minister of its intention to avail itself of the provisions of Bill C-211 in the announcement made yesterday by the government of that province with respect to family allowances, can the minister say if he is satisfied that the government of the province of Quebec would not use those funds to recuperate moneys from the federal government in order to pay out social benefits that were intended as family allowances in Quebec?

**Hon. Marc Lalonde (Minister of National Health and Welfare):** Mr. Speaker, under Bill C-211 family allowances that will be approved by this House will be paid directly by the federal government to the citizens of the province of Quebec as in other provinces. So with that method it is impossible for a province or a provincial government to allot to any other purpose the funds voted by parliament as family allowances.

**Mr. Rondeau:** Mr. Speaker, I have a supplementary.

I thank the minister for his answer but does he mean that those allowances will be paid directly to the recipients rather than the province?

**Mr. Lalonde:** Mr. Speaker, I think I was quite clear in my reply, but I will try to further clarify it.

The amounts voted by the parliament of Canada for family allowance purposes will be paid by the federal government directly to the citizens in each of the provinces where those amounts are to be paid, and not to the provincial governments.

**Mr. Reilly:** Mr. Speaker, this question does not refer to new employees or new classifications. These are employees who suddenly, after having worked in the service in one case for 26 years, have been asked to fill out forms.

**Mr. Speaker:** Does the hon. member have a supplementary?

**Mr. Reilly:** I should like to ask the Prime Minister once again to investigate this fact and report.
