PUBLIC SERVICE—PERSONNEL WHO FORMERLY WORKED IN THE OFFICE OF THE PRIME MINISTER OR FOR ANY OTHER MINISTER

Question No. 159-Mr. Clark (Rocky Mountain):

What was the (a) name (b) position (c) job description of every individual presently in the Public Service of Canada who worked in the Office of the Prime Minister, in the Privy Council Office or as a Research Assistant, Special Assistant, Executive Assistant, Secretary, Advisor, Consultant or in any other capacity in or for the office of any Minister or Minister of State from 1963 to the present?

Hon. Mitchell Sharp (President of the Privy Council): A reply to this question would require the review of personal files of every individual employed in the Public Service of Canada. In view of the workload involved, the Government does not feel justified in undertaking such a review. Employees of the Privy Council Office have always been members of the Public Service. The remaining individuals described in the question may have been members of the Public Service on leave of absence, while attached to the Office of the Prime Minister, a Minister or Leader of the Opposition in the House of Commons and thereafter returned to public service assignments. The exempt staff of the Prime Minister, Ministers, the Leader of the Opposition in the House of Commons, Leader of the government in the Senate or Leader of the Opposition in the Senate may be appointed to the Public Service under Section 37 of the Public Service Employment Act. Parts (3) and (4) of Section 37 set out the "Rights on termination of employment" of such employees while part (5) assigns the determination of the "Order of appointments to the Public Service Commission". The statutory base for appointments to Ministers' office dates from 1918 "Civil Service Act". In 1929, the 1918 Act was amended to include appointments to the office of Leader of the Opposition plus an amendment dealing with appointment of such individuals to the Public Service on termination of exempt employment. In addition to the appointment procedure set out in Section 37 of the Public Service Employment Act, any person may apply for Public Service employment and if vacancies exist, selection proceeds via normal Public Service Commission selection processes.
