Mr. Goodale: I ask, Mr. Speaker, that the remaining questions be allowed to stand.

Mr. Brisco: Mr. Speaker, if there were some difficulty with question No. 506 which was placed on the order paper on October 14 last, I would understand the problem the government might have in responding to my question. However, in view of the fact that it is a straightforward and simple question I would think someone within the Post Office Department should be able to answer it, and I would like to register my concern.
