I am not asking for a witch hunt; I just want to find out whether or not the government is pursuing an investigation of former Nazis presently resident in this country. It is a simple question and it is about time it was answered.

Mr. Smith: Madam Speaker, I will again endeavour to see what can be done to expedite the answer in this matter.

CANAGREX ACT

MEASURE TO ESTABLISH

The House resumed, from Monday, January 25, consideration of the motion of Mr. Whelan that Bill C-85, an Act to establish a corporation called Canagrex to promote, facilitate and engage in the export of agricultural and food products from Canada, be read the second time and referred to the Standing Committee on Agriculture.

Mr. Marcel Dionne (Chicoutimi): Mr. Speaker, I am happy to have an opportunity to speak to Bill C-85. Agriculture is certainly one industrial sector in Canada that needs improved marketing mechanisms. Yesterday I listened to a number of speeches about the objectives of Canagrex, and I know, Mr. Speaker, that many opposition members had serious doubts about the effectiveness of Canagrex. Now, Canagrex did not come out of the blue. It was planned through close co-operation and consultation with all farmers' groups and associations throughout Canada, and I can say that especially in Quebec, the vast majority of farmers are very positive about this new corporation. Furthermore, this kind of organization is already well known in international markets and Canagrex is certainly not creating a precedent. I should like to point out to my colleagues on the opposite side that many, if not the majority of foreign governments have had agencies to deal with the export of agri-food products for a number of years. Some examples are SOPEXA in France, Britain's board for farm products exports, AGREXCO in Israel and CONASUPO in Mexico. The reason why these agencies were established is that an increasing number of countries want to negotiate on a government-to-government basis. The advantage of such negotiations is mainly that they offer government protection in addition to providing for speedy assembly of a stable export
