PRIVY COUNCIL DEFINES POWERS OF PARLIAMENT. Lancaster Marriage Bill is Ultra Vires, is Finding of Judicial Committee of Empire's Highest Court--Power is Delegated to Provinces -- Quebec Question Disposed of.

London, July 29.—Judgment was rendered today by the judicial committee of the Privy Council in the first case submitted to their consideration by the Dominion government on the marriage question. The holding of the law lords is substantially in accordance with the decision of the Canadian Supreme Court in its leading point.

The Real Question. Lord Haldane continued that in the course of the argument submitted it became apparent that the real controversy between the parties was as to whether all questions relating to the validity of a contract of marriage including the conditions of that validity, were within the exclusive jurisdiction conferred on the Dominion parliament by section 91. If this is so, then the provincial power extends only to the directory regulations of the formalities by which the contract is to be authenticated, and does not extend to any question of validity.

Notwithstanding the able argument addressed to them, their lordships decided at the conclusion that the jurisdiction of the Dominion Parliament does not, on a true construction of the provisions of the B. N. A. Act, cover the whole field of validity. They consider that the provision in section 92, conferring on the provincial legislatures the exclusive power to make laws relating to the solemnization of marriage in a province, operates by way of exception to the powers conferred on the Dominion Parliament.
