JOINT RESOLUTION

Authorizing and requesting the Secretary of State to enter into negotiations with the Dominion of Canada with reference to the straightening and deepening of the channel of the Roseau River north of the international boundary line.

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That the Secretary of State be, and he is hereby, authorized and requested to initiate and enter upon negotiations with the Government of the Dominion of Canada with a view to the straightening and deepening of the Roseau River north of the international boundary line between the United States and Canada, so as to increase its capacity as a drainage outlet for the water coming from the lands within the watershed of said river both in Canada and in the United States, so as to make same susceptible of reclamation by drainage, and report to Congress the result of such negotiations.
