Also, an Act made and passed in the same year, intituled, "An Act to empower and authorize the Justices of the County of Westmorland, at their General Sessions of the Peace, to regulate the grazing and depasturing of the several Marshes, Low Land, or Meadows within the said County," will expire the 7th day of March next.

- Act 3 Geo. IV. intituled "An Act to regulate the cutting of Saw Logs on the River Magaguadavic and its various branches," will expire on the first day of April next.
- Act 4. Geo. IV. intituled "An Act for the encouragement of Parish Schools in the Province," and the Act 9th and 10th of His said late Majesty, in amendment thereof, will expire on the first day of April next.
- Act 7. Geo. IV. intituled "An Act to provide for the expenses of the Judges holding the Circuit Courts and the Courts of Oyer and Terminer in this Province, and of the Clerk of those Courts," will expire the 7th March next.

Act, made and passed in the same year, intituled "An Act for regulating the Salmon and Shad Fisheries, so far as the same may relate to the River Peticodiac, in the County of Westmorland," will expire on the 31st day of March next.
