

QUESTIONS—*Continued.*

11. To appoint a select committee to inquire into the causes of the inundation on 12th April, 1865, in St. Pierre, Sorel, Berthier, and other Parishes on the St. Lawrence, 95.

12. That the renewal of the Reciprocity Treaty with the U. States is an object of the utmost importance, and in order to secure that object, it is expedient that the enlargement of the Welland and St. Lawrence Canals should be prosecuted at the earliest possible period; Moved in amendment to a question of Supply, and negatived, 97.

13. To appoint a select committee to inquire as to the person who signed and sent a telegram, in the name of Mr. Alex. Dufresne, M. P. for Iberville, addressed to J. B. Bourgeois, 136.

14. That the House do now adjourn, 233.
