Special Train on the B. & L. H. Branch Runs into the Rear End of a Local Train at Paris-A Drumbo Lady and Her Daughter Killed. Paris, Ont., March 1.-This afternoon, about 4 o'clock, a special train from Brantford, on the B. & L. H. RR., ran into the rear end of the local train going west, which was standiug on the same track at at this station. The engine struck the rear passenger car and drove it forward, under

HARRISON'S CABINET.

The Make-up That Receives Most Credence.

Washington, March 1.-The impression prevails in some circles to-night that the Cabinet of the incoming Administration is complete with one exception, and that no further change will be made in the slate as at present arranged. This is the make-up that receives most credence:-Secretary of State, James G. Blaine; Secretary of the Treasury, William Windom; Secretary of War, Redfield Proctor; Secretary of the Navy, to be filled; Secretary of the Interior, John F. Swift; Attorney-General, John W. Noble; Postmaster-General, Jno. Wanamaker; Secretary of Agriculture, Jeremiah Rusk. It is said that Platt and Miller are distinctly out of the race, and the Platt men are much annoyed. Debate on the Address Continued-Mr. Morley's Amendment Rejected by 339 to 260.


