

Clause 10

Strike out line 15, on page 7, and substitute the following therefor:

"(2) A permit shall contain such terms and"

Strike out line 43, on page 7, and substitute the following therefor:

"is authorized, it shall specify the period, not in excess of one year, for"

Clause 11

Strike out lines 7 to 15, on page 8, and substitute the following therefor:

"11. (1) Where the Minister grants a permit or varies the terms or conditions of a permit, a copy of the permit and its terms and conditions or of the terms and conditions so varied, as the case may be, shall be published in the *Canada Gazette*.

(2) Except in the circumstances described in paragraph 9(5)(c), publication pursuant to subsection (1) shall be made before the first day on which dumping, or loading for the purpose of dumping, is authorized in accordance with

(a) the permit, or

(b) if the terms and conditions of a permit have been varied, the terms and conditions so varied."

Clause 12

Strike out line 24, on page 8, and substitute the following therefor:

"subsection 10(4), other than in accordance with the recommendations of a report referred to in subsection (7),"

Strike out line 37, on page 8, and substitute the following therefor:

"sisting of not more than three persons, of whom the Chairman shall not be a public servant, and"

Clause 13

Strike out line 22, on page 10, and substitute the following therefor:

"not exceeding seventy-five thousand dollars."

Clause 14

Add immediately after subclause (6) the following:

"(7) Subsection 450(5) of the *Canada Shipping Act* is not to be construed so as to relieve any person from any liability under this Act."

Clause 20

Strike out lines 1 to 3, on page 15, and substitute the following therefor:

"20. (1) The Minister may designate as an inspector or analyst for the purposes of this Act any person who, in his opinion, is qualified to be so designated."

Clause 28

Add immediately after subclause (2) the following:

"(3) The Minister shall, within three months after the 31st day of December in each year, cause copies of any reports that he has made in the preceding year pursuant to the Convention to the organization responsible under the Convention for secretariat duties in relation to the Convention to be laid before Parliament or, if Parliament is not then sitting, on any of the first fifteen days next thereafter that Parliament is sitting."
