Mr. CASTLEDEN: If you want to make your little speech go right ahead. I am talking of what I saw of unemployed people in this country.

Mr. PURDY: What did you do to provide work for those who were unemployed?

Mr. MacNICOL: Did you ever give a man a job?

Mr. CASTLEDEN: I have found it hard enough to find a little job for myself. But I know that there were a million unemployed people in this country. This bill is just like trying to put a patch on an old worn-out tire. The bill provides that after the returned soldiers have forced their former employers to give them work, the employers must keep them in work for six months. What happens after that? We do not know. There is no question that the reestablishment and rehabilitation of the returning men is most important, but I want to tell the administration and those who are responsible for this bill that the working men and soldiers of Canada do not want a reestablishment of the old set-up that they had in Canada a few years ago. The right of every man to exchange his labour for a decent living must be recognized.

Mr. MacNICOL: I agree with that.

Mr. CASTLEDEN: But that right has not been recognized in the past, and unless we do something to see that the men shall have that opportunity-and this bill does not provide itthen I say we are failing to do our duty.

Section stands.

Progress reported.

PRAIRIE FARM ASSISTANCE ACT

AMENDMENT OF PROVISION RESPECTING DECLARA-TION OF EMERGENCY YEAR

Hon. J. G. GARDINER (Minister of Agriculture) moved for leave to introduce Bill No. 14, to amend the Prairie Farm Assistance Act. 1939.

He said: The bill contains only one section. It provides for the removal of section 3 (1), which reads as follows:

Any crop year in which the average price is less than eighty cents per bushel may be declared by the governor in council as an emergency year under this act.

And substitutes therefor:

The governor in council may for the purpose of this act declare any crop year to be an emergency year.

It takes out the restriction of eighty cents a bushel.

Motion agreed to and bill read the first time.
