CYPRUS-REQUEST FOR STATEMENT ON PRESENT POSITION

On the orders of the day:

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, I would ask the Secretary of State for External Affairs whether he can give the house a report on the present situation in Cyprus, particularly whether in the last day or so there have been any signs that the situation is alleviating.

Hon. Paul Martin (Secretary of State for External Affairs): Mr. Speaker, the situation in Cyprus is that the government of Turkey has relented in respect of a position it had announced it was going to take with regard to the sending of supplies to the island, an act that was thought to contain elements of provocation. The decision now is that the Turkish government, in response to an appeal by the United Nations secretary general to postpone the sending of the shipment, has agreed to do so if the United Nations will provide the necessary arrangements for further food shipments to reach Kokkina. Arrangements are being made to this end.

This has considerably eased the situation. As the right hon, gentleman knows, the secretary general has circulated a report with regard to the operation of the force, and this will be considered by the security council on Thursday, I think.

Mr. Diefenbaker: Would the minister say whether there has been any agreement on the part of Canada to continue its force in Cyprus indefinitely, or whether a limitation has been placed on the availability of the Canadian force?

Mr. Martin (Essex East): There has been no decision by the Canadian government to contribute forces indefinitely, nor has there been any decision reached as to further participation in the force. CONGO-REFUSAL TO PERMIT REMOVAL OF CANADIAN CITIZENS
