Some hon. Members: Hear, hear.

Mr. Baldwin: We have nothing to resign from.

Some hon. Members: Resign.

Mr. Speaker: Order, please.

Mr. Eldon M. Woolliams (Calgary North): If questions in reference to the Department of Transport, and in particular those with regard to housing are to be answered, will the Prime Minister inform the house whom the acting minister in the house to answer these questions will be.

Mr. Trudeau: As the hon. member knows, the roster system does not provide for the Minister of Transport to be present in the house today.

An hon. Member: How about tomorrow?

Mr. Trudeau: As for tomorrow, I can assure the house that there will be a minister answering questions with regard to the department.

Mr. Baldwin: How about the Holy Ghost today?

Mr. Speaker: Order, please. I bring to the attention of hon. members that many questions have been asked on what I realize is an important point, and I see that another seven or eight hon. members are anxious to ask supplementary questions on this subject. However, the hon. member for Témiscamingue and other hon. members are anxious to ask questions on other matters, so I

GROUNDFISH FLOOR PRICE-SALT COD POLICY

Mr. James A. McGrath (St. John's East): I have a question for the Minister of Fisheries and Forestry which arises out of the statement released by the department today. Has the minister defined a floor price for groundfish, and has the department worked out the mechanics for the purchasing and receiving of the groundfish mentioned in the press release?

Hon. Jack Davis (Minister of Fisheries and Forestry): The answer is yes, the department has worked out the mechanics of this purchasing arrangement, both with the trade and in concert with some of the other fish exporting countries selling frozen groundfish in the United States. The Fisheries Prices Support Board will be buying at market prices fish which is offered at any price below the prevailing market price, with a view to supporting the price and bidding it up to a point where it covers the basic costs of our efficient Canadian producers.
