Right Hon. P. E. Trudeau (Prime Minister): Obviously, I cannot give this guarantee, Mr. Speaker. The issue depends on the discussions that are going on over there. Canada's position is quite simple. I hope hon. members of the opposition will support it and will agree that only Canada, a sovereign state, can participate as a member in international conferences.

Mr. Asselin: Mr. Speaker, I should like to put a supplementary question to the Prime Minister.

Can he tell the House whether it is true that Canada has categorically turned down the French proposal, which would mean that she would not participate in the cultural agency that would be established?

Mr. Trudeau: Mr. Speaker, I am not sure if I can answer this question without knowing exactly which French proposal is being referred to. Several have been made. Indeed, amendments and subamendments have been proposed. We would have to know which one the hon. member has in mind.
