OIL SPILL INTO ATHABASCA RIVER-REQUEST FOR UNANIMOUS CONSENT TO MOVE MO-TION UNDER S.O. 43

Mr. G. W. Baldwin (Peace River): Mr. Speaker, I should like to move a motion of a type with which Your Honour is now famil-[Mr. Kierans.]

As the Standing Committee on Transport Standing Order 43 and I ask unanimous consent to move the motion under these circumstances.

> The oil spill into the Athabasca River has now reached epic and dangerous proportions. It is now backing up into the Peace River, will be entering the Slave River and may well go into Great Slave Lake. At this time of year the flood waters in the area of the confluence of these rivers are very substantial.

> In view of what has happened and the fears that have arisen, and in view of the fact that additional pipelines to be constructed in the north are now under contemplation, I think this matter should be one for immediate inquiry. I therefore move, seconded by the hon. member for Parry Sound-Muskoka (Mr. Aiken), the following motion, to which I ask for the unanimous consent of the House:

> That, in the opinion of this House, the government of Canada and the government of Alberta should immediately discuss the establishment of a commission of inquiry into the question of the oil spill in the Athabasca River; the adequacy of the means taken to deal with the damage and the establishment of proper safeguards and precautions against any repetition of this disastrous pollution.

> Mr. Speaker: Hon. members have heard the motion proposed by the hon, member for Peace River. By the terms of Standing Order 43 this motion requires the unanimous consent of the House. Therefore the Chair has to inquire whether there is such unanimity.

Some hon. Members: Agreed.

Some hon. Members: No.

Mr. Speaker: Since there is not unanimity the motion cannot be moved at this time.

RATE INCREASE REQUESTED BY BELL CANADA -REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

Mr. David Orlikow (Winnipeg North): Mr. Speaker, I rise under the provisions of Standing Order 43 to ask the House to agree to a motion regarding Bell Canada. Bell Canada has made a request to the Canadian Transport Commission for a new increase in telephone rates of 61 per cent.
