### Question No. 1,670—Mr. McKinnon:

Did the Department of National Defence order, from Canadian Arsenals Ltd., \$7,064,016 worth of pyrotechnical equipment under contract number MA40.3689205 and, if so (a) what exactly is included under the general term "pyrotechnics" (b) for what purpose?

Mrs. Ursula Appolloni (Parliamentary Secretary to Minister of National Defence): Yes. In response to the Department of National Defence contract demand 3689205, Supply and Services Canada entered into a contract with Canadian Arsenals Limited for the supply and delivery of pyrotechnical equipment to the Department of National Defence.

- (a) 120,000 handfired parachute flares. This contract also includes the purchase from the Swiss manufacturer of the manufacturing rights and special production tooling by Canadian Arsenals on behalf of the government.
- (b) This item is used by the land forces as illuminating device.
