# **CULTURAL AFFAIRS**

#### CANADA-UNITED STATES TALKS—GOVERNMENT POLICY

Hon. Perrin Beatty (Solicitor General of Canada): Mr. Speaker, as the Hon. Member will know, there is still the possibility that that particular decision may be appealed in the courts in which case we should wait until the outcome of the appeal. I have indicated to previous questioners in the House that I remain with an open mind. I am anxious to receive the various points of view of various people including Chiefs of Police, Attorneys General and others.

I have read in the press that the Attorneys General would like to meet with me to have a discussion about the Young Offenders Act. I would be delighted to do so. Additionally, I have indicated that I will be soliciting points of view on this matter in a very broad way and I will be apprising the House of the results.

Ms. Lynn McDonald (Broadview-Greenwood): Mr. Speaker, my question is for the Prime Minister and concerns cultural integrity. Last week the Prime Minister said in the House that our cultural industries would not be negotiable in any discussions on free trade that might take place. However, in Halifax on Sunday the Minister of Communications said that they might be negotiable and certainly that they would not be exempt. Would the Prime Minister clarify the Government's policy? Are our cultural industries up for grabs or will there be a full exemption from free trade for cultural industries?

Right Hon. Brian Mulroney (Prime Minister): Mr. Speaker, I have not seen the statement alleged by my hon. friend but I think I can be reasonably certain that the Minister of Communications made no such statement because the position of the Government and the position of his Department are the protection of the integrity of our cultural institutions. It might come as some surprise that it was a Progressive Conservative Government which, of all things, founded the CBC. We believe in the protection of the integrity—

Mr. Gray (Windsor West): You're now wrecking it.

Mr. Mulroney: The Liberal House Leader says that the CBC is wrecking the Government. On the contrary; we work hand in hand with the CBC at all times. We believe in its integrity and independence.
