I have another petition which is very similar to the first ones. It is signed by 17 senior citizens who belong to Le Club d'âge d'or de St. Eugène in the federal riding of Glengarry-Prescott-Russell, which is represented very ably by my colleague on my right. These petitioners are requesting that the Government ensure that Bill C-26 does not contain discriminatory provisions and that the provisions apply equally to all senior citizens.

I have another petition from Le Club d'âge d'or de Treadwell in the federal riding of Glengarry-Prescott-Russell. These petitioners are petitioning the Prime Minister (Mr. Mulroney) and the Conservative Government to ensure that Bill C-26 does not contain any discriminatory provisions with respect to senior citizens. Senior citizens have contributed immensely to the—

**Mr. Nunziata:** Mr. Speaker, I am glad you agree that it is an important issue. It is for that reason my colleagues and I have presented a number of petitions.

The final petition I wish to present today is signed by 36 residents who belong to Le Club D'Age D'Or de Wendover in the federal riding of Glengarry-Prescott-Russell. These 36 senior citizens are deeply distressed by the discriminatory provisions contained in Bill C-26, and they are asking the federal Government to ensure that those discriminatory provisions do not continue to exist in Bill C-26.
