Major-Gen. Hutton Closes Up the Camp Canteens.

Compliments for the First Hussars From Commanderin-Chief

soldiers Forbidden to Wear Unauthortzed Badges-Brigade and Division Orders-An Uneventful Day.

Yesterday was an uneventful day at the military camp, having been devoted to putting the finishing touches on, squad and section drill. All day Gen. Hutton rode through the lines and over the fields, inspecting the movements of the several battalions. Perhaps the most interesting thing to the soldier is the loss of his beer. The canteen privilege is one that, as a rule, has been greatly abused. A rushing business was done on Tuesday night, the first night in camp, and Gen. Hutton, as usual, was around "taking in the sights." The commander-in-chief issued an order to have every canteen closed at once, which was done to the great surprise of those brave defenders who were afflicted with a deep thirst.

The First Hussars were put through a number of movements yesterday afternoon by Gen. Hutton, and Lieut.-Col. Gartshore was congratulated by the general on the proficiency of the men. They were addressed by Gen. Hutton, when he told them that he had come among them to help them, and not to discourage them by criticism.

FIRST BRIGADE ORDERS. Major Stuart, of the Twenty-sixth, was field officer today, and Major Kittermaster will perform that duty tomorrow. Capt. Waldo, Thirty-second Bruce, will be brigade captain. The Twenty-first furnished the duty band, lying-in picket and brigade guard today, and the Thirty-second Battalion will perform these duties tomorrow. Orders will be issued from the brigade marquee at 12 o'clock noon. Grocery rations will be served at 6 a.m. in future instead of 6 p.m.

The orders for the second brigade are issued by Lieut.-Col. Buchan, commanding officer. Major Moscrip, Twenty-eighth Perth Battalion, was field of-ficer today, and Major Allen, Wellington Rifles, will perform this duty tomorrow. Brigade captain, Capt. Quinn, Oxford Rifles; brigade quartermaster, Capt. Wissler, Wellington Rifles. The Twenty-ninth Waterloo Battalion will

furnish the duty band tomorrow.

The wearing of civilian hats or any article of civilian clothing by non-commissioned officers or men in camp is strictly prohibited.

The bands of the brigade will be massed for practice of regimental marches at forenoon and afternoon parades (9:45 and 2:15 respectively), in rear of lines of Thirtieth Wellington Rifles, under the direction of Bandmaster Trendell, Wellington Rifles.

At all drills men will not be permitted to lie down while standing at ease, except at the periods which will be designated by the bugle call down." On the bugle sounding up," drill must be resumed at once. Mail will be collected at the officers'

marquee of each battalion at 8 am. and 1 p.m., and delivered at 9:30 a.m. and 2:30 p.m. The Rev. Mr. Farthing, chaplain of

the Oxford Rifles, will hold a service in the lines of that battalion every morning, at 6 o'clock, lasting for ten minutes only. All officers, non-commissioned officers and men wishing to attend will be cordially welcomed. DIVISION ORDERS.

The attention of all ranks is called to paragraph 1,953, Queen's regulations, and orders for the army, relating to the wearing of unauthorized badges.

Dominion Government Are Inquiring Into the Matter.

A Discussion on the Alien Labor Law - The rrinciple of Ministerial Responsibility.

Ottawa, June 1.-Mr. John Ross Robwere called, asked the attention of the government to the enforcement of the alien labor law in this country. the alien labor law in this country. He asked if it was intended to enforce the law as regards the importation of aliens from the States to take the place of the striking trackmen on the G. T. R. He read a report of an interview with Inspector DeBarry, of Buffalo, in which the inspector stated most emphatically that the alien labor law was still in force, and so far as he knew there had not been any talk of suspending it. Mr. Robertson said the strike was a justifiable one, and he denounced the G. T. R.'s "miserliness." The men whom the G. T. R. were importing were not native Americans, and there was no large force of public opinion in the United States which would offer one word of protest if the Canadian Government had only the courage to do what was right

in this matter. Sir Wilfrid Laurier expressed regret that so grave an issue should be approached in a manner calculated to inflame passion. His own sympathies, he said, were just as strong with the strikers as were Mr. Robertson's, but he would be sorry to prejudice the question until he had heard both sides. Why should he not wait to hear the defense of the Grand Trunk before pronouncing judgment? Mr. Robertson, added the premier, warmly, was over-zealous in this matter, not so much because of his sympathy with the strikers, as to make political capi-tal. When the government had a demand from the men themselves to enforce the alien labor law, and the gov-ernment refused, would be time enough to complain, and up to the present moment no such demand had been made.
"Therefore," said he, "under the circumstances Mr. Robertson is simply over-reaching himself for the purpose, not of favoring the interests of the men whom he pretends to serve, but simply to gratify his own political spite. Now, with regard to the law itself, let me say that we have not an official understanding with the American authorities that the alien labor law is to be suspended. A law cannot be suspend-

"As I said yesterday," concluded Sir Wilfrid, "I beg to repeat, that at this moment the matter is engaging the attention of the government, and we are applying ourselves to it. I repeat that when the trackmen come to us and make their complaint we will hear that complaint and give it every possible consideration and attention."
Sir Charles Tupper accused Sir Wil-

frid of losing his temper. He complained that Canada was not receiving justice. We had suspended the operation of the alien labor law, but the United States law continued to be enforced against Canadians. He could quite see the reasonabless of the government of the United States and the Government of Canada doing all they possibly could to remove every source of irritation between the two countries pending these negotiations, but the Government of Canada should take that this should not be a onesided arrangement, and that while they, in good faith, were observing the understanding, the United States should be required to observe it also.

Mr. George Taylor dwelt on the danger to the traveling public, and said the government would be responsible

for any accident. Mr. Blair said that if there was any way in which the government could be satisfied that they could efficiently interfere in this trouble they would be only anxious to do it. He did not know how it would be possible for them to interfere with any effect at all in the present juncture, or how he could make this end in a satisfactory way to the

people concerned.

Various other speeches were made, including one by Mr. Logan (Lib.), who said it was disgraceful that in this Canada of ours we should have thousands of operatives who were on strike because they received only the mean, insignificant salary of 97 cents

a day.

Sir Charles Tupper moved a resolution affirming the principle of ministerial responsibility. It read partly as follows: "This house is further of the opinion that the ministers of the crown, having entire control over the public departments, they are bound to assume responsibility for every of-ficial act. This house is further of the opinion that ministers of the crown should not permit blame to be imputed to any subordinate for the manner in which the business of the country is transacted, except only in cases of personal misconduct, for which the political heads have the remedy in their own hands."

THE PROPOSITION IS ALL RIGHT. Sir Wilfrid Laurier said he noticed with great pleasure, yet without any surprise, that when his right honorable friend has a sound proposition to offer to the house he can do it in very few words. (Hear, hear.) When he has an unsound proposition to make, his remarks are very long, apparently in an effort to convince the house. On this occasion, however, he could not find any fault with the proposition laid down, which embodied the A B C of parliamentary government. He could not be expected to offer opposition to the motion, any more than he could had the proposition been to put upon the re-cords of the house the Ten Command-ments. It was within the recol-

lection of the house that in the early part of the session an honorable mem-ber attempted to hold the government responsible for the alleged misconduct of officers of the government. The honorable member for Pictou attempted to hold the government responsible for charges which were made against Major Walsh of misconduct while he was administrator of the Yukon, According to the principle here laid down, how could the government be responsible for personal charges against Major Walsh?
