No. 9.—A copy of the transmission through the Governor by the Supreme Court, for the approval of the Crown, of such rules and orders as may have been promulgated in that Court, during the year 1834, as required by the charter.

No. 10.—A copy of affidavits sworn to before a Magistrate to justify the swearing in of Special Constables under the 1st and 2nd William 4, cap 41, together with the names of the Special Constables sworn within the year 1834, and the Magistrates before whom sworn.

A Petition of William Evans and others, principal Inhabitants of Grand Bank in Fortune Bay, was presented by Mr. Hoyles, and the same was received and read setting forth, that the population of the aforesaid settlement of Grand Bank are equally fast increasing in number, and in vice, misrule, and disorder, and that the Petitioners have no adequate means of checking the growing evil—there being no place of confinement to which to commit the disorderly—no Gaol, Stocks, or even Irons of any description, by which the small civil authority established there might exert the power invested in them. That the depressed state of the Fishery and the poverty of the Inhabitants, in general, prevent them from raising the necessary sum for erecting a small gaol or place of confinement,—and praying that the House will take their case into consideration, and grant them such pecuniary or other assistance as in their wisdom may seem meet.

Ordered, that the said Petition do lie upon the Table.
