I know that the means by which some assistance, either direct or indirect, could be made available to supplement the rescue operations which are being assisted by the United States and United Kingdom forces are being actively explored. The United States and the United Kingdom had armed forces stationed quite close by and they were able to be of very substantial assistance in this disaster. As soon as more details are available as to what is urgently needed—I have heard something to the effect that it is blankets and medical supplies—we will all be in a better position to determine what could or should be done.

Big news of the week was the Bank of Canada temporarily withdrawing its support from government bond prices.

On page 4 I found a little story headed. "Government Bond Prices Hold After Sharp Drop". The main part of the story is a repetition of the statement I made last week in answer to the hon, member for Kamloops. I cannot see where that is the big news of the week, even by the Financial Post's standards. The second point is that I have nothing to add to the statement I made on government policy last week. I would point out, however, that this very story in the Financial Post does say that bonds of comparable issues of both the United Kingdom and the United States have fallen more over the same period.
