Hon. Otto E. Lang (Minister of Justice): Mr. Speaker, the answer to the first part of the question is no. I have no intention of discussing the matter with them at the present time.

ROYAL CANADIAN MOUNTED POLICE

PROTESTS AGAINST REMOVAL OF INITIALS FROM BUILDING AND VEHICLES IN EDMONTON

Mr. Don Mazankowski (Vegreville): Mr. Speaker, I should like to direct a question to the Solicitor General arising out of statements made last Friday. Has the minister received any formal protest, internal, external or otherwise, concerning the removal of the initials "RCMP" from the building and vehicles of the Edmonton RCMP detachment? If so would he so indicate, and will he be making a statement on motions to clarify this issue as it has alarmed many people, particularly in western Canada?

Hon. Jean-Pierre Goyer (Solicitor General): Mr. Speaker, this is an administrative decision that was taken by the Commissioner himself on November 4, 1969, as to the principle, and on October 19, 1970, as to the details. In fact, this decision of the Commissioner is widely known, since the new sign has appeared on RCMP buildings for two years already, and more particularly in Saskatoon since June 1971. So, I cannot see why there is such an alarm all of a sudden.

Now, I can make the whole series of signs used by the Royal Canadian Mounted Police available to hon. members, and I wish to emphasize that the words Royal Canadian Mounted Police appear twice and the words Gendarmerie royale du Canada once and I believe three times is sufficient.

REMOVAL OF NAME FROM BUILDING IN SASKATOON

Right Hon. J. G. Diefenbaker (Prince Albert): I would like to ask the minister, because his memory was not very good the other day, whether or not on the building in Saskatoon the words "Royal Canadian Mounted Police" no longer appear?

Hon. Jean-Pierre Goyer (Solicitor General): Mr. Speaker, the word "police" is very clearly written and everybody can see the RCMP shield which has shown, since 1873, the motto "Maintiens le droit" as well as the words Royal Canadian Mounted Police. All that is very clear. The answer is yes.

Mr. Diefenbaker: Mr. Speaker, this verbose minister does not answer the question. I asked him simply whether the designation "RCMP" has or has not been removed. I have his letter here, in case he has forgotten it, indicating that the reason RCMP was removed was that it would not blend with contemporary buildings. What an explanation!
