INQUIRY AS TO POSSIBILITY OF CONTROLLED USE OF DDT TO KILL MOSQUITOES AND BLACK FLIES

Mr. G. W. Aiken (Parry Sound-Muskoka): Mr. Speaker, I wish to direct a question to the Minister of Agriculture. Is the government considering the controlled introduction of DDT for residential and recreational spraying of mosquitoes and black flies? I ask this question because of certain reports that have been circulated.

Hon. H. A. Olson (Minister of Agriculture): Mr. Speaker, there may be some consideration going on from time to time by an interdepartmental committee respecting this matter because it is charged with the responsibility of looking at alternatives, but I know of no action that is contemplated immediately in this regard.

Mr. Olson: We are, Mr. Speaker, but it is too simple to say it is an alternative because there are alternative products for some purposes and there are no satisfactory alternatives for other purposes.

In view of the very severe ban the United States has placed on the use of DDT, is there cross-research between the two countries? Are we exchanging research information on the control of DDT and on the search for alternatives?

Hon. H. A. Olson (Minister of Agriculture): Yes, Mr. Speaker, and I should remind you, Sir, and the House that we did restrict the purposes for which DDT could be used by about 90 per cent only a few months ago.
