ABORTIONS—INQUIRY AS TO JUSTICE DEPARTMENT INVESTIGATION OF FACILITIES AVAILABLE

Mr. Stuart Leggatt (New Westminster): Mr. Speaker, my question is directed to the Minister of Justice. Some time ago it was reported in the Ottawa newspapers that officials in his department had been concerned about the number of abortions that were taking place in this country and that was to be looked into. I want to ask the minister whether he is also having his officials investigate the number of hospitals in this country which have refused to set up abortion committees and the number of areas in which there are no abortion facilities available for Canadian women?

Hon. Otto E. Lang (Minister of Justice): No, Mr. Speaker. That would not come within the responsibilities of the Minister of Justice.

I have had some consultations with the government House leader and he may be able to throw a little more light on when the bill may be brought before the House than I can, Mr. Speaker.

ALLEGED DETENTION OF TWO ESKIMOS IN PREVILLE HOSPITAL—REQUEST FOR INVESTIGATION

Mr. John Harney (Scarborough West): Mr. Speaker, as a week has passed since the hon. Minister of Indian Affairs and Northern Development told me he would answer my question the next day, could I ask him today, once again, if he has asked the officers of his department to ascertain the situation of the Eskimos at the Preville Hospital in Brossard?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, on two occasions last week I tried to rise and answer the question, but unfortunately I could not get the floor.

I am happy to answer today. A nurse went with an interpreter to the Preville Hospital. The two Eskimo patients who are there are well treated and the report is that the situation should not be changed. However, we will follow all possible developments and if the patients are not comfortable there, they will be moved to another hospital.
