POSSIBILITY OF INTRODUCTION OF LEGISLATION BEFORE PUBLICATION OF GREEN PAPER—GOVERNMENT POSITION

Mr. Jake Epp (Provencher): Mr. Speaker, I have a question for the Prime Minister. Yesterday the Prime Minister stated that any interim measures to change immigration regulations would be announced by the government in the House. Later he stated that the opposition could express its point of view if the government makes a statement on motions on the subject. In the light of the statement made by the Minister of Manpower and Immigration yesterday, has the government changed its position and will any significant interim changes in the immigration policy be undertaken by the government which will be debated in the House?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I will have to inquire if there will be legislation before the green paper. I understand from the House leader that there might be one small bill, but of course it will be brought to the House and debated here. I do not quite see the relevance with regard to the exchange yesterday, but perhaps I did not understand the purport of the hon. member's question.

Mr. Epp: Yesterday the Prime Minister was asked very clearly as to whether legislation would be brought to the House respecting any changes that are proposed by the government on the immigration policy. For some time now the government has carried on a study in preparation of the green paper.

Mr. Speaker: Order, please. Has the hon. member a supplementary question to pose to the Prime Minister and, if so, will he please pose it, otherwise we should be getting on to another question?

Mr. Epp: I asked the Prime Minister whether, in view of the fact that the green paper has been completed, any legislation making significant changes in the present policy on immigration will be introduced in the House prior to the publication of the green paper.

Mr. Trudeau: Yes, Mr. Speaker, as I indicated, there will be a very small bill on another subject than those which were discussed yesterday. But I must correct the hon. member with regard to something he said. The green paper is not completed, as he seems to assume. It will be completed in due course and brought before parliament.
