### Death of Golda Meir

On the second part of the question, I think it would be desirable to address a question to the President of the Treasury Board (Mr. Buchanan) at an early date as to what his plans for that bill are in 1979. I think the question should be asked, and I think the minister will want to answer it, but I am not in a position to answer it today.

**Mr. Knowles (Winnipeg North Centre):** Mr. Speaker, can we have an agreement that the debate today should last until five o'clock and that there then be no recorded votes?

Mr. Speaker: Is that agreed?

Some hon. Members: Agreed.

Mr. Speaker: So ordered.

In keeping with the practice we have been following recently, may I presume, since this day has now become the day for dealing with the supply bill and as the House has now agreed to proceed in a certain manner, that it is in order to introduce the supply bill at this hour of the day under introduction of bills in order that it can be distributed? ## **CANADIAN HUMAN RIGHTS ACT**

AMENDMENT TO EXTEND PROVISIONS TO FEDERAL EMPLOYEES

**Mr. Stuart Leggatt (New Westminster)** moved for leave to introduce Bill C-447, to amend the Canadian Human Rights Act.

Some hon. Members: Explain.

**Mr. Leggatt:** Mr. Speaker, the purpose of this private member's bill is to make it abundantly clear that the Canadian Human Rights Act is intended to apply to all federal employees, including the staffs of the Senate and the House of Commons who, under this particular legislation, at the present time are excluded. The bill further extends the protection of the Canadian Human Rights Act to employees of companies which carry on business in Canada and which are in receipt of federal government contracts or subsidies of any kind.

Motion agreed to, bill read the first time and ordered to be printed.
