9. Is Canada committed to the purchase of any further shares?

Mr. Cossitt: Madam Speaker, I rise on a point of order. I note that *Hansard* of yesterday, Wednesday, makes no mention at page 2509 of the usual notices of motions for the production of papers. BANK ACT AND QUEBEC SAVINGS BANKS ACT

MEASURE TO EXTEND OPERATIONS UNTIL NOVEMBER 30, 1980

Hon. Pierre Bussières (for Deputy Prime Minister and Minister of Finance) moved:

That Bill C-39, to amend the Bank Act and the Quebec Savings Banks Act, be read the second time and referred to the Standing Committee on Finance, Trade and Economic Affairs.

He said: Madam Speaker, I will be very brief in my comments. Every member of the House is very much aware of the purpose of this bill which seeks to amend section 6 of the Bank Act and of the Quebec Savings Banks Act to allow Canadian chartered banks to extend their operations by virtue of these two acts until November 30, 1980. Without this bill, banks would not have the legal power to continue their operations beyond next July 14.

It now seems obvious that Parliament will not adopt the government proposals contained in this bill before July 14,
